

SPEAKER: Brad Dacus

Founder & President-Pacific Justice Institute



Brad Dacus earned his Juris Doctor from the University of Texas School of Law. With a fervent dedication to constitutional rights, Brad founded the Pacific Institute (PJI) in 1997. PJI has since grown into one of the largest Christian non-profit organizations, offering legal—free of charge—services to defend faith and family.

Addressing legislation that impacts religious freedom and parent’s rights, Brad has testified before the US House of Representatives in Washington D.C., and has also testified on several occasions before the California State Legislature. Today, he visits and speaks at many churches, conferences, graduations, and conventions across the United States.

With a reach spanning over 1,000 radio stations, Brad is a regular voice on the “Dacus Report”, and delivers a succinct legal commentary, “The Legal Edge”, broadcasted on more than 800 radio stations weekly.
