

## THE GETTYSBURG ADDRESS

Four score and seven years ago our fathers brought forth upon this continent, a new nation, conceived in liberty, and dedicated to the proposition that all men are created equal.

Now we are engaged in a great civil war, testing whether that nation, or any nation so conceived and so dedicated, can long endure. We are met on a great battle-field of that war. We have come to dedicate a portion of that field, as a final resting place for those who here gave their lives that this nation might live, It is altogether fitting and proper that we should do this.

But in a larger sense, we cannot dedicate—we cannot consecrate—we cannot hallow—this ground. The brave men, living and dead, who struggled here, have consecrated it, far above our poor power to add or detract. The world will little note, nor long remember what we say here, but it can never forget what they did here. It is for us, the living, rather to be dedicated here to the unfinished work which they who fought here have thus far so nobly advanced.

It is rather for us to be here dedicated to the great task remaining before us, that from those honored dead we take increased devotion to that cause for which they gave the last full measure of devotion; that we here highly resolve that these dead shall not have died in vain; that this nation, under God, shall have a new birth of freedom, and that this government of the people, by the people, and for the people shall not perish from this earth.











Charlie Kirk was an American conservative political activist and radio talk show host. He co-founded the conservative organization Turning Point USA with Bill Montgomery in 2012, and served as its executive director since. He was CEO of Turning Point Action, Students for Trump, and Turning Point Academy, Turning Point. In his latest years, he became recognized as one of the most prominent voices of the MAGA movement in the Republican Party.

A key ally of Donald Trump. He exposed a variety of conservative stances, including opposition to abortion, gun control, DEI programs, and LGBT rights. His moral controversial views included his criticism of the Civil Rights Act of 1964 and Martin Luther King Jr, his promotion of COVID-19 misinformation and false claims of electoral fraud in 2020, and his opposition to immigration.

On September 10, 2025 Kirk was shot and killed while speaking at a TPUSA public event at the Utah Valley University campus. His death gained international attention and led to the condemnation of political violence by prominent dominant domestic and international figures. President Trump announced that Kirk would posthumously receive the Presidential Metal of Freedom.

#### **VOTER ID AND POISON PILL INITIATIVES**

We are proceeding full steam ahead with our signature drive to qualify the CA Voter ID initiative with a launch of Oct. 1. That's the same time when Prop 50 election ballots arrive in mailboxes, so we will use our army of signature gatherers as the "ground game" to educate voters to oppose Prop 50. As promised on Monday I filed the "Poison Pill" Redistricting Initiative to bar any politician who engages in midcycle redistricting from running for any office for 10 years! We expect to be cleared for signature collection on that in late October. The timing could not be better!

We have a plan to FIGHT- but the ballots for the special election will arrive in mailboxes in just 3 weeks from now.

The polling shows even blue California voters support the independent Citizens' Redistricting Commission by a 2-to-1 margin—so we can WIN this fight if we mobilize ASAP and get everyone's help. I know I ask for your help a lot, but I can't fight this battle alone. My job is to come up with the plan, and hope people are willing to fight as volunteers and contributors every step of the way. 
