Members of Third Mutual Board were present at the meeting, including Mark Laws, President; Ralph Engdahl, M&C Chairman; and Donna-Rane Szostak, Treasurer.

Attendees asked many questions of the presenters and Third Borad Members who were present. The bulk of the concerns involved lack of response from requests to Resident Services and lack of communication to Building Captains when maintenance services were being performed, including status of projects and when projects have been completed.

Eileen Paulin, VMS Director of Media and Communications was also present and addressed changes that are in process to the Village communication systems, including Service Requests. These new systems should improve the areas of most complaint.

Mark Laws was asked whether the water in underground garages when it rains is being addressed and Mark said that it is being worked on.

In the meantime, here are GVA suggested procedures that we can use to improve response to service requests:

- Email your request to <u>ResidentServices@vmsinc.org</u>. When you call in a service request the odds of the service rep transcribing it correctly and it going to the right department are much less than 100%. Also, without an email request, you do not have a record of what happened, which makes it more difficult for the GVA to effectively help.
- 2. If you do not receive a ticket # for your request, there is a high probability that it will not be done.
- 3. If you do not receive a useful response within 5 days, contact your Regional Rep for help. Here is the list of Regional Reps and the buildings in each Region:
