

Travel Tip—Many countries require your passport to be valid for at least 6 months after your departure. Look up your destination's entry requirements at <a href="travel.state.gov/destinatlion">travel.state.gov/destinatlion</a> and check your passport expiration date before booking flights.

#### BIDEN'S TAX PLAN THAT PUTS AMERICA LAST

I am often asked if President Joe Biden is intentionally trying to dismantle the American economy with his imbecilic energy, climate change, crime, border, inflation and debt policies. But I've always believed these policies are driven by a badly mistaken ideology—not malice.

Biden thundered that he was going to make corporations "pay their fair share," the Democrats in Congress leapt to their feet in applause.

When I read through the details of Biden's new multi-trillion-dollar tax plan, it's hard to come up with any plausible explanation other than he's trying to make American industry less competitive. Biden's tax scheme would hobble United States businesses with nearly the highest corporate tax rate in the world—higher than our primary competitors.

They're the big winners here if (God forbid) these policies were adopted. Even China and Russia—one communist nation and one autocratic nation—would have LOWER tax rates on their businesses than we would on ours.

This helped attract more than \$1 trillion back into the United States from all corners of the globe—from Switzerland to Bermuda to Euroland. It helped raise incomes from working-class Americans despite being disparaged as a "tax cut for the rich." As Trump once put it, because of the lower tax rates and other pro-growth reforms, for the first time in decades factories moved from Mexico to Maryland rather than the other way around.

Meanwhile in Ireland the 12.5% corporate tax rate has helped make that nation the fastest-growing land in all of Europe. They even have a budget surplus. That's right. The lower tax rates have ushered in revenue.

But Biden and the Democrats would rather bash big business for not paying "their fair share" than fix the problem sensibly. Ironically, the one industry in America that pays virtually no business tax is the green energy colossus. Why don't we start with making THEM pay their fair share, which clearly isn't zero?

The White House estimates their plan will raise \$500 billion over a decade from corporations. Of course, corporations are owned by 130 million Americans with 401 (k) plans and other retirement packages.

Economist Kevin Hassett, who was Trump's chairman of the Council of Economic Advisers, has shown corporate tax rates are statistically inversely related to worker wages. Lower tax rates mean higher worker cay.

So blue-collar America will pay a large share of the Biden tax hike's burden.

But the Biden economics team is in denial about the science. They reject the real-world evidence that high tax rates deter job growth and investment, they ignore the Ireland experience, and they pretend the rich will earn all the burden of a tax that will hurt all American workers and consumers while benefiting our global competitors.

These insane tax-hike policies will put America last—literally and figuratively.

# THE TOP TEN REASONS TO OPPOSE THE AMENDMENTS TO THE INTERNATIONAL HEALTH REGULATIONS

- CHANGE FROM ADVISORY TO MANDATORY: Change the overall nature of the World Health Organization from an advisory organization that merely makes recommendations to a governing body whose proclamations would be legally-binding. (Article 1 and Article 42)
- POTENTIAL RATHER THAN ACTUAL EMERGENCIES: Greatly expand the scope of the International Health Regulations to include scenarios that merely have a "potential to impact public health." (Article 2)
- DISREGARD FOR DIGNITY, HUMAN RIGHTS AND FREEDOMS: Seek to remove "respect for dignity, human rights and fundamental freedoms of people." (Article 3)
- 4. ALLOCATION PLAN: Give the Director General of the WHO control over the means of production through an "allocation plan for health products" to require developed states parties to supply pandemic response products as directed. (Article 13A)
- MANDATORY MEDICAL TREATMENTS: Give the WHO the authority to require medical examinations, proof of prophylaxis, proof of vaccine and to implement contact tracing, quarantine and TREATMENT. (Article 18)
- 6. GLOBAL HEALTH CERTIFICATES: Institute a system of global health certificates in digital or paper format, including test certificates, vaccine certificates, prophylaxis certificates, recovery certificates, passenger locator forms and a traveller's health declaration. (Articles 18, 23, 24, 27, 28, 31, 35, 36 and 44 and Annexes 6 and 8)
- 7. LOSS OF SOVEREIGNTY: Would empower the Emergency Committee to override decisions made by sovereign nations regarding health measures and would make the Emergency Committee's decisions final. (Article 43)
- UNSPECIFIED, POTENTIALLY ENORMOUS FINANCIAL COSTS: Redirect unspecified billions of dollars to the Pharmaceutical Hospital Emergency Industrial Complex with no accountability. (Article 44A)
- CENSORSHIP: Greatly expand the World Health Organization's capacity to censor what they consider to be mis-information and dis-information. (Annex 1, page 36)
- OBLIGATIONS OF DUTY TO COOPERATE: Creates an obligation to build, provide and maintain IHR infrastructure at points of entry. (Annex 10)

## TAKE A TIP FROM RONALD REAGAN ON HANDLING CAMPUS PROTESTS

The year was 1966, and Ronald Reagan was running for governor of California.

A major part of his platform was to "clean up the mess at Berkeley "and other college campuses throughout the state that were experiencing protests and strikes over issues that included the military draft, civil rights and "women's issues."

While that wasn't on a scale of pro-Hamas, anti Israel, anti-American and anti-Jewish hatred we are witnessing now on several college campuses, Reagan's response could instruct current college presidents and admissions officers to quell the unrest.

In a campaign speech, Reagan said many leftist campus movements had transcended legitimate protest, with the action of "beatniks, radials and filthy speech advocates" having more to do "with rioting, with anarchy" than "academic freedom."

He faulted university administrators and faculty who "press their particular value judgments" on students, for "a leadership gap and a morality and decency gap" on campus, and suggested a code of conduct he imposed on faculty to "force them to serve as examples of good behavior and decency."

Morality, good behavior and decency appear to be electives, not requirements, on too many of today's campuses whose "students" (and apparently not all are students) are now running the institutions of what might be called learning.

Six months after becoming governor in 1967 Reagan wrote a letter to Glenn Dumke, chancellor of San Francisco State College, who opposed the unrest occurring on many California campuses.

In it, Reagan condemned "these people and this trash" who used "the excuse of academic freedom and freedom of expression" to justify continuation of the protests.

"We wouldn't tolerate this kind of language in front of our families."

He called on Dumke to "lay down some rules of conduct and promised you'd have (all the) backing I could give you."

We need to hear more of this type of talk to counter the anarchists and hatred of Jews and Israel and support of terrorist organizations on today's college campuses.

Even more than talk, action is needed.

The Rockefeller Brothers Fund and the Open Society Foundation headed by George Soros have reportedly been contributing hundreds of thousands of dollars to leftist organizations that funnel money to groups that are behind these campus upheavals.

At a minimum, the IRS should take a look at their tax-exempt status to see if they have violated regulations pertaining to what is allowable for nonprofits.

The government should also look at whether any of those shouting antisemitic and anti-American slogans are here on student visas. If they are, those visas should be revoked and the students deported Others who are found guilty of giving aid and comfort to terrorists should be expelled.

Some wealthy donors to Columbia University and other schools have pledged to withdraw financial support if order and decorum are not restored.

All of this feeds the view that America is coming apart.
