

#### **USGA STANDARDS**

### guide play at Laguna Woods Village

Golf is rooted in tradition, including dress codes, course etiquette and proper golf cart usage. While not every scenario can be documented or a sign placed, all players and their guests are expected to understand basic sports etiquette and ask questions when unsure.

Here at Laguna Woods Village, we follow the standards set by the United States Golf Association (USGA). Additionally, there are course specific guidelines in the golf operating rules found here. Refer to section M for course specifics.

A portion of the USGA rule 1 is below:

- Acting with integrity Follow the rules, apply all penalties and be honest in all aspects of play.
- **Showing consideration to others** Play at a prompt pace, look out for the safety of others, and don't distract the play of another player.
- Taking good care of the course Replace divots, smooth bunkers, repair ball-marks and don't cause unnecessary damage to the course.

### **RESIDENT GOLFER ACHIEVES** RARE 'GRAND SLAM'



# One Club Length or Two?

If you are taking relief from an abnormal course condition, such as cart paths, ground under repair or obstructions, this is considered "free relief." No penalty strokes are assessed. To proceed, identify the nearest point of complete relief that is not closer to the hole, then measure one club length from that spot. The measurement must be taken using the longest club in your bag, other than your putter.

If your ball lies in a penalty area marked with red or yellow stakes and you choose to take relief, first determine the point where your ball last crossed the margin of the penalty area. From there, you may take two club lengths of relief, but you will incur a onestroke penalty.



To ensure fairness and protect resident privileges, all golfers are now required to check in with their resident ID card in hand.

We have recently seen cases where multiple resident IDs were used to allow non-residents to play at the resident rate. This

undermines the system designed to provide benefits exclusively for our community members. Please remember:

- Present your own valid resident ID at check-in.
- Show your resident ID every time you play.

If a non-resident is found playing without having paid the guest rate, the entire group may be asked to leave and the incident will be referred to the Compliance Division.
