## CART PATH ONLY

After heavy rain, turf conditions may be too soft to support golf cart traffic without causing damage. When staff determine this condition exists, the course will be designated "Cart Path Only."

Cart Path Only means all four tires must remain on the cart path at all times. Failure to follow this restriction can result in loss of playing privileges for the day and may impact decisions about opening the course during wet conditions.

Thank you for helping protect the golf course and maintain quality playing conditions.



## PROJECTS, FEES AND RULES

### MULCH PROJECT

Mulch is being added in select areas of the golf course to help conserve water and reduce maintenance in less frequently used sections. If your ball lands in a mulched area, you may find it easier to play from than the hard ground or longer grasses previously in place.

Mulch is considered a loose impediment and may be moved, provided the ball itself remains in position. These areas also offer a softer surface than standard turf, which should improve overall playability.



### ANNUAL TRAIL FEE

Golfers who use personal carts on the 27-hole course will see the annual trail fee charged to their member account in January. The \$65 fee will appear on the statement emailed on February 1. All personal carts must be registered with Resident Services.

### RULES CORNER

When a bunker is declared "Ground Under Repair" due to conditions such as flooding, it is treated as part of the general area under Rule 16.1b. To take relief, identify the nearest point of complete relief outside the bunker that is not closer to the hole and free from interference. From that point, drop the ball within one club-length, ensuring it is not closer to the hole and provides complete relief.



## RESIDENT ID REMINDER FOR GOLF CHECK-IN



All residents are reminded that a resident ID is required to access all Recreation amenities, as outlined in Section 1A of the GRF Recreation Policy. A link to the policy is available for those who wish to review it.

Golf staff are required to verify the resident ID of every player at check-in to ensure fairness and consistency. While staff may recognize some residents, others may not, and staffing may vary throughout the day. Requesting ID from all players ensures the policy is applied equally.

ID verification also helps prevent access issues related to expired or invalid IDs. Recently, a familiar individual was asked to present their ID and it was discovered that it had been turned in after moving out. Checking IDs at each visit helps ensure compliance with Recreation Department policies.

Southern California offers many great days for golf, but there are times when weather conditions require a delay. When fog is too dense for safe play or frost could damage the turf, a weather delay will be called.

Once a delay is declared, players with tee times will be notified that early tee times will be lost. When play resumes, the current tee time will be announced at the first tee.

## FOREUP LOVES CHROME

ForeUP recommends using the Google Chrome browser when booking tee times, as other browsers are not supported. Using Chrome helps ensure the most reliable and consistent booking experience.

If Chrome is not already set as your default browser, you can follow the steps outlined in this short video to make the change:

If you experience trouble logging in, first confirm that you are using Chrome. If issues persist, clearing your browser history often resolves the problem. In Chrome, select the three dots, usually located in the upper or lower right corner of the screen, choose the option to delete history, and select "all time." Please note that these steps may vary slightly depending on your device, such as a phone, tablet, or computer.

Also be aware that any passwords or saved links from your previous browser will not automatically transfer to Chrome.

## WEATHER CONDITIONS AND DELAYS

Groups whose tee times were lost will be offered the option to start on the course at the point they would have reached without the delay. For example, if fog lifts at 8:30 a.m., a 7:00 a.m. group may be offered the opportunity to play only a portion of the back nine.

Players who are unable to complete a full round will be offered a nine-hole rate.

These procedures affect the fewest number of golfers possible, as delays are typically short. Thank you for your understanding.
